

Bridges Golf Course Tournament Contract

Thank you for selecting Bridges Golf Course for your tournament or group outing.

This contractual agreement has been prepared between the Bridges Golf Course and the tournament organizer. Forming the contract are the rules & regulations and the tournament function and contract sheet.

Bridges Golf Course agrees to provide the golf course and relevant amenities as detailed in the contract. In consideration of these services;

- The client agrees to abide by the rules and regulations of the Bridges Golf Course (please see attached).
- The client ensures that the Bridges Golf Course and its employees shall not be held liable for any personal injury, or loss or damage to personal property suffered by the convener. Should any damage occur to the course or any of its equipment the client agrees to pay for any and all damages without hesitation.
- ***A 25% deposit (greenfee & shared cart rate) is required by May 15th 2008. All shotgun tournaments are subject to a \$ 1000.00 deposit. Any booking after May 15th,2008 must provide a deposit (see above) upon reservation.*** Balance of the total cost is required the day of the event unless special payment plans have been agreed upon by both parties. **All deposits are non-refundable.**
- ***All clients must confirm numbers for golf at least 72 hours in advance and 72 hours for clubhouse food & beverage.*** A 5% modification of your confirmed number (with the exception of shotgun tournaments) of players will be accepted without penalty. After that time all cancellations or changes are subject to full charge and will be billed accordingly.
- Tournament groups are considered any pre-arranged group of 20 players or more. All tournament greenfees and powercarts will be reserved and paid under one master bill. All groups of 20 or more players MUST reserve and use powercarts.
- Bridges Golf Course requires a list of players and cart groupings at least 48 hours prior to your tournament to allow ample time for function set-up and administration. No changes to the draw will be accepted after this time.
- Weather cancellations will be made by the club and the Head Professional only. At the time of a cancellation due to weather the Head Professional and tournament convenor will arrange an alternate date.
